Resolution #71 of 2020 – Resolution to Proceed with the inter-connecting the City of Cortland's and the Town of Cortlandville's Municipal Water Distribution Systems.

Whereas, the City of Cortland, (City) and the Town of Cortlandville, (Cortlandville) the water distribution systems, (system/s) share adjoining physical locations, and

Whereas, the Town's system in operating near capacity, and

Whereas, the City's system is operating below capacity, and

Whereas, it is more cost effective for the Town to purchase water from the City than to construct and operate a new pumping station, and

Whereas, it is in the interest of the City to have a contingent access to the Town's system should unforeseen circumstance arise that limits the City's ability to pump, treat, and distribute water to City users, and

Whereas, the Town shall bear the costs to construct an interconnecting system, and

Therefore, Be It Resolved that the City of Cortland shall cooperate with the Town of Cortlandville with the process of drafting an inter-municipal agreement for the inter-connection of systems subject to final and mutual approval of the City's Common Council and the Town's Board of Trustees.

The City has the capacity to generate more water than what it is utilizing or selling and this will help Cortlandville.

Resolution #72 of 2020 – Resolution to spend \$5,000 from contingency on DRI branding/information.

The DRI will have 10 million dollars of which \$300,000 of that went to consultants, leaving approximately 9.7 million and bout 4 million went to private projects and over 5 million going to public projects. There is a complete reconstruction of Main Street, conduit for high speed fiber optic cable, art portion and the pocket park. There is also a loan/grant fund in the amount of \$600,000 to help enhance and stimulate businesses in the downtown core. Those five major projects are going to be taking place and this is a good opportunity to make sure we are consistent in terms of getting information out to constituents. This is a onetime investment from the City of \$5,000, Convention & Visitors Bureau \$5,000, Chamber of Commerce \$5,000 and BCDIA \$5,000.

Item #7 - Discussion on the City's trash and recycling.

An email was sent to Council regarding complaints. The change came because of County changes and City took the less expensive way. People have the option of opting out of the program. Private haulers need to follow the same guidelines as the City hauler. The City could draw up standards and talk about passing at least 1 local law that would make sure that we are consistent in terms of expectations of haulers in the City. If a private hauler is collecting trash in the City, they are collecting recyclables consistent with expectations of the City and of New York State. There is a possibly to have private haulers be required to license through the City. DPW is working to get flyers out by the end of March.

<u>Item #8</u> – Discussion on Capital Funding.

Mack Cook stated that over the last six months a group of individuals have been working on twenty three active projects. There is a timeline of projects and funding of projects. Mack will do workshops with Council if desired to go into further detail.
